
The Robert M. Rainey Philanthropy Award is presented to a philanthropist in the Oconee, Pickens, and Anderson County area who has made significant contributions to the betterment of the community. On Tuesday, November 15th, founding board member John Miller presented the 2021 Rainey Award to Charles and Libby Dalton at a luncheon in their honor.

Charles Dalton is President and CEO Emeritus of Blue Ridge Electric Cooperative, retiring in 2018 after 36 years. Under his leadership, the company's Blue Ridge Fest grew to one of the largest charity fundraisers in the Upstate, donating more than \$2.7 million to human help organizations since its beginning in 1998. With a background in business, public relations and marketing, **Libby Dalton** rose to CEO of the Pickens County YMCA, the first woman in South Carolina to serve in this capacity. Both have served tirelessly throughout the upstate in charitable and community service organizations.






