During this time in our history we are experiencing some major changes. Cindy Kibler announced her retirement effective December 31, 2023 as our Director of Donor Services – a role she has had for 24 years. While we celebrate her outstanding tenure of service to the Foundation and the broader community we welcome Mary R. Pickens as our new Director of Donor Services. Mary recently returned to Anderson after a number of years in Iowa as a mission focused nonprofit program manager. She has the skills and talents to help the Foundation navigate the changes ahead that are a result of our continued growth in overall assets and in grant distributions. 

FOUNDATION WELCOMES TWO NEW TRUSTEES FOR 2024

William Kenley and Brian Cauthen have been elected to serve four-year terms on the Foothills Community Foundation Board of Directors beginning January 1.

William Kenley has served as Chief Executive Officer of AnMed since September 2020. Kenley was most recently an executive vice president at Methodist Le Bonheur Healthcare based in Memphis, Tennessee, where he served in progressive leadership roles since 2004. He completed his Master of Health Administration at Duke University and received his undergraduate degree from Radford University. He and his wife, Carol, have two children, Jack and Grace.

William is a Fellow of the American College of Healthcare Executives. He received a Bachelor of Science from Radford University (1987) and a Master of Health Administration from Duke University (1991) and completed an administrative residency with Geisinger Health System (1992).
